Graduate, Law and Physician Assistant students **MUST ENROLL AND CONTINUE TO BE ENROLLED FOR AT LEAST 3 CREDIT HOURS** for summer semester to be considered for Federal Direct Stafford/Ford Loans. Failure to maintain at least 3 credit hours will result in all Federal Direct Stafford/Ford Loan funds being removed from your account. "WF" and "WU" grades can result in reduced credit hours and the removal of your financial aid. Financial aid cannot be reinstated if cancelled once the enrollment period has ended.

Summer financial aid is based upon an average enrollment of five (5) credit hours for graduate and law students, or six (6) credit hours for physician assistant students. If you are enrolled for more than the average enrollment and you have remaining Federal Direct Stafford/Ford Loan eligibility, you may request an increase in your cost of attendance beginning June 22, 2009. Cost of attendance increases will not be processed for ILP (Individualized Learning Program) classes.
